

# Announcement of HARIS 2014 facts heets

#### **HARIS 2014 Factsheets**

The results of HIV/AIDS Response Indicator Survey (HARiS) 2014 conducted by the Department of Health are now available. HARiS 2014 is a behavioural and seroprevalence survey that covered five vulnerable groups, namely men who have sex with men (MSM), male-to-female transgender persons (TG), clients of female sex workers (FSWC), female sex workers (FSW) and injecting drug users (IDU). HARiS also monitors the coverage and effectiveness ofcollective the community response. The HARiS findings have been compiled as factsheets with bilingual versions available at the Virtual AIDS Office website (http://www.aids.gov.hk/).



# A Summary of the 35th CFA Meeting held on 18 March 2015

### Review of local HIV situation 2014 and revision of HIV/AIDS Report Form

DH presented the local HIV situation in 2014 and the HIV care cascade. Issues about cases with undetermined route of transmission, refusing to receive medical care and loss to follow-up were discussed. DH emphasized that incomplete data collection by the HIV/AIDS Report Form (DH2293) had made analysis difficult. With recent revision and Chinese version available, members were reminded to submit the form for every confirmed positive case. They were also encouraged to continue their good effort in providing HIV testing so as to narrow down the largest gap of "link to diagnosis" along the HIV care cascade.

### How life skills affect the sexual health status of youth community

AIDS Concern presented the findings of a survey on young people's knowledge on HIV and sexually transmitted infections (STIs) and their sexual behaviours. They concluded that while the youth population had good knowledge on HIV and STIs, they lacked the life skills to practise condom use. They stressed the importance of life skills-based education (LSBE), targeted approach to young MSM and making use of outreach and online channels to close the gap between knowledge and practice. Others suggested sex education should be extended to the tertiary levels.

### **Supplementary results of HARiS 2014 – Injecting Drug Users (IDU)**

DH presented the descriptive statistics of HARiS 2014 – IDU after incorporating data from SARDA. In summary, the needle sharing rate remained high (24.3%) and condom use at last sex with regular partners had dropped by around 10% compared to 2013. Members were reminded to remain vigilant for the situation of needle sharing in view of the drop in quality of heroin as well as its cost rise. The increase in tendency for local IDU to share needles with Mainlanders was also a concern.

#### Other issues

DH informed members of the new stand by Expert Panel for allowing HIV-infected health care workers to perform exposure prone procedures on a case-by-case basis under specified conditions. Regarding discussion about drug rehabilitation services provided by NGOs, members were advised to directly contact the Secretary of the Drug Liaison Committee of the Narcotics Division under Security Bureau for further follow-up.

## Dr.Tim Brown's Consultancy Visit (13-17-April 2015)

In March 2015, DH has engaged Dr Tim Brown as an external consultant to advise on the enhancement of HIV surveillance in Hong Kong and support strengthening the response. He is the Senior Research Fellow of the East-West Center in Hawaii and an international expert on HIV epidemiology and HIV/AIDS epidemic modelling. During his visit to Hong Kong in April 2015, he met with ACA members, DH and NGOs to share his views on the local HIV situation.

### Meeting with NGOs



Dr Tim Brown met with representatives from nine AIDS NGOs to review HARiS 2013 & 2014 and discuss the way forward.

### Familiarization workshop on applying the AIDS Epidemic Model (AEM) for Policy Analysis



Colleagues from Special Preventive Programme, Surveillance and Epidemiology Branch of Centre for Health Protection, and the Chinese University of Hong Kong School of Public Health attended a two-day workshop on AEM conducted by Dr Tim Brown.

Dr Tim Brown presented his synthesis and interpretation of the current HIV epidemiology in Hong Kong.
