## Results of the HIV/AIDS Response Indicator Survey (HARIS) 2015

#### **Background**

As a continuation of HARiS 2013, the Special Preventive Programme (SPP) of the Department of Health (DH) conducted HARiS 2015 to monitor the risk behaviours of at-risk populations accessed by NGOs through their HIV community programmes. The five at-risk populations comprised men who have sex with men (MSM), male-to-female transgender persons (TG), clients of female sex workers (SWC), female sex workers (FSW) and injecting drug users (IDU). The same set of common response indicators developed by Dr. Tim Brown, external consultant from East West Center, continued to be used

#### Methodology

The survey was conducted from April to June for MSM, TG and SWC; and from June to August for FSW and IDU. Fourteen NGOs participated in the survey. Subjects were recruited in various settings and through different channels including NGOs' service centres, bars, saunas, massage parlors, construction sites, vicinity of Methadone Clinics (through venue outreach) and social media and discussion forums (through online outreach).



#### **Conclusion**

Compared to HARiS 2014, condom use rate improved among MSM, TG, FSW and IDU, but decreased in SWC. However, the condom use rate of MSM when having sex with emotional relationship partner and regular sex partner was sub-optimal. The target recommended in the ACA strategies (2012-2016) is that last sex condom use should be at least 70%.

HIV testing rate among five groups was generally similar to last year, being highest among FSW and IDU (>70% tested in previous one year) and lowest in SWC (36% tested in previous one year). However, considering the high risk of HIV infection among MSM and TG, their current past year testing rate of 60% was below optimal levels. With the rising trend of newly reported MSM HIV infections in recent years, promotion of annual HIV testing should be strengthened among the MSM community.

Although needle sharing rate in IDU dropped significantly by over 10%, sharing outside usual network (such as with strangers and pick up used needles) remained similar to last year. The number of newly reported HIV infection among IDU remained low in recent years, but the potential risk of local cluster outbreak and sudden upsurge of HIV infection in this population should not be underestimated. HIV prevention efforts and education on the risk of needle sharing are crucial and should be maintained.
