

Strategy Series

THE Committee on Education and Publicity on AIDS (CEPAIDS) has started a new Strategy Series on priority areas in HIV prevention. The strategies are developed during CEPAIDS



meetings - so far two (one on men who have sex with men, MSM and the other on mobile population) have been started and are now in progress. The strategy papers would document current knowledge and recommend directions in the local setting, with a societal persepctive and practical approach.

The new series is developed to stimulate interest in the community, catalyse targeted prevention efforts, and provide a forum for refining future strategies. The series would become one first step towards building a bridge between the Committee and the community. The strategy development process will be a dynamic one requiring input from the community, reviewing and updating

The Coalition was boycotting the Conference because of the controversy surrounding the International Church of Christ, which supported the event, and the insufficiency of consultation with the local community. Harm Reduction in Hong Kong

DR Robert Newman, MD, MPH will be visiting Hong Kong on 23 and 24 September. He will be in Hong Kong as the Lions Visiting Scholar 1998, to provide consultation at a workshop on HIV and harm reduction in Beijing and also to meet with people working on harm reduction in Hong Kong.

Dr Newman is no stranger to Hong Kong. He

helped design Hong Kong's addiction treatment programme in 1975, and has been a pioneer in methadone maintenance. In March 1994 (see *ACA Newsfile* April 1994) he visited Hong Kong again to advise on harm reduction strategy.

Dr Newman is currently the CEO of Continuum Health Partners, Inc, which controls Beth Israel Medical centre, St Luke's-Roosevelt Hospital Centre and Long Island College Hospital. He is a Professor of Epidemiology and Social Medicine, and of Psychiatry. (Dr David Ho was the Lions Visiting Scholar 1997)

TWENTY-SIX participants joined in a forum titled "Ethical Considerations of HIV/AIDS Research and Intervention with Special Population" at the Red Ribbon Centre on 20 August. Organised by the AIDS Advocacy Alliance, the forum stimulated active discussion on the subject. In a message posted after the forum, the AIDS Advocacy Alliance urged the Government to show their confidence in the community planning process recommended in the external consultancy report (see page four of this newsletter). The forum also suggested further meetings, drawing up of ethical guidelines, opening up of avenues of communication, and building ethical consideration into the community planning process.

Community Planning how to go about

THE following is a letter from the Secretariat to Miss OC Lin of Hong Kong Coalition of AIDS Service Organisations (HKCASO), dated 1 August, on the proposed community planning process to be implemented soon:

I refer to our phone conversation yesterday. The Chairman has asked me to convey to you his heartfelt appreciation for the encouraging response of HKCASO given in your letter of 25 July as regards our review. As you may have already known, the Advisory Council on AIDS is examining the external consultancy report with a view of exploring means of carrying its recommendations forward. In this connection. community planning is prioritised as one important area in moving Hong Kong's programme forward.

The Council realises

the importance of wide consultation in the development of this new initiative. The input of the community at this stage would naturally be essential. In view of the broad representation of HKCASO, the Council wishes to invite the Coalition to propose a plan on the setting up of the communityplanning process in Hong Kong. This should be designed using the framework provided in the external consultancy report (pages 31 to 36), with the objective of "drawing up specific activities in key areas and identifying capacity building needs". We are sure that with your support, and through your consultation with all community sectors, including AIDS-NGOs. mainstream NGOs, PWA and academics, an effective communityplanning process can be established.

Thoughour external consultants had kindly proposed a model (in the report) to work on, we feel it necessary to frame it appropriately to address

local needs. In this context, we are hoping that HKCASO can make specific proposal on:

- 1. how to form the communityplanning committee or group, and what its terms of reference should be;
- 2. its composition, with refinement as necessary, and their justifications;
- 3. the time frame for the committee/ group's operation;
- 4. the mechanisms which the committee/ group could utilise in drawing up the sets of specific activities; and
- 5. prioritising the areas listed on page 35.

We hope that a proposal can be available before 28 August, which would then be examined by the Advisory Council on AIDS at its next meeting in September.

The chairman, other Council members and the Secretatriat shall be grateful to discuss with you further should there be queries.
